Mayor Provo called the meeting to order and led in the Pledge of Allegiance.

Mayor Provo opened the Public Hearing for Parcel Based Zoning Project.

Mayor Provo stated the project was proposed to the Village by the Livingston County Planning Department's Heather Ferraro and Shawn Rooney. The purpose of the project is to make minor adjustment (tweaks) in the zoning district lines to move as many parcels as possible into one zoning district or add measurements to the zoning map so that the property owner and the Zoning Department will be able to more quickly identify what distract a specific property is in.

The project was turned over to the Joint Village/Town Planning Board and the Village Zoning Board of Appeals. When the project started the number of properties in more then one zoning district was eighty parcels. After first agreeing on the location of the zoning districts the number of effected properties dropped to seventy.

The Village was then sectioned off into four areas and effected residents were invited to attend meeting addressing their effected properties in each section as the project progressed. Based on the size of the area of the project (seventy-nine acres), a long form SEQR was required and has been completed. Mayor Provo showed the public the current zoning map and the maps with the proposed changes. Mayor Provo informed the room of two recommendations the Village board made changes to and one property that was left in multiple zoning districts based a request from the owner.

Mayor Provo also stated the project would be on the February County Planning board's agenda. The Village Board will be not be voting on the amended map until we receive the County Planning Boards comments.

Mayor Provo stated for the record that he owned a property affected within this project. Trustee Rawleigh also stated he owns a property affected within this project.

The following residents asked questions regarding the project:

- Pat Smith-25 Connors Ave. regarding the zoning of his property and why it is MH not R1. Mayor Provo started with MH is least restricted.
- Sam Chripriano- 72 Grove Street- regarding the size of the industrial area of his property. Mayor Provo started the area of the industrial zone in its whole was moved west.
- Chuck DiPasquale- 1 & 3 Damonsville Street regarding the old gravel pit is still industrial. Mayor Provo stated "Yes"
  - Mayor Provo stated that the tax value won't be affected by this project.
- Ken Mancini- 7 Van Dorn Ave. is questing why his property is moving into the MH district. Mayor Provo stated that MH is less restricted for the current property use.
