WHEREAS, the Village of Mount Morris submitted and was awarded a Water Quality Improvement Program Grant (WQIP) under the Round 14 of the Consolidated Funding Application (CFA) process on behalf of the Village, for upgrades to their WWTP Disinfection Project; and

WHEREAS, to estimated cost of the Project is projected to be \$340,000.00; and

WHEREAS, that the Village of Mount Morris Board of Trustees, has been awarded the DEC program grant award in the amount of \$289,000.00 on behalf of the Village for WWTP Disinfection Improvements to partially offset the cost of the Project; and

**RESOLVED,** that the Village of Mount Morris authorizes and appropriates a minimum local match as required by the Water Quality Improvement Program for the WWTP Disinfection Improvements. Under the WQIP program, this local match must be at least 15% of the WQIP grant award of up to \$289,000. The source of the local match, and any amount in excess of the required match, shall be provided through the sewer fund. The Mayor may increase this local match through the use of in kind services without further approval from the Village Board.
