RESOLUTION OF THE VILLAGE BOARD OF THE VILLAGE OF MOUNT MORRIS TO HOLD REFERENDUM OF THE ELECTORS OF THE VILLAGE OF MOUNT MORRIS TO APPROVE THE ESTABLISHMENT OF THE MOUNT MORRIS FIRE DISTRICT

WHEREAS, the Town Board of the Town of Mount Morris and the Board of Trustees of the Village of Mount Morris held a joint public hearing on July 29, 2019 at 6:00 p.m. at the

Livingston County Campus Auditorium, located at 1 Murray Hill Drive, Mount Morris, New York, for the purpose of jointly considering the formation of a joint fire district, at which time the Boards heard all those wishing to be heard on the question of the formation of said joint fire district; and

WHEREAS, the Town Board of the Town of Mount Morris and the Board of Trustees of the Village of Mount Morris held a joint public meeting on March 6, 2020, for the purpose of holding additional discussion on the topic of the formation of the Mount Morris Fire District; and

WHEREAS, the Town Board of the Town of Mount Morris and the Board of Trustees of the Village of Mount Morris resolved, on March 6, 2020, that it is in the public interest to form the said Mount Morris Fire District, and that said joint fire district be formed and established, subject to referendum as provided in sections 94 and 189-a of the Town Law, and contingent on the favorable vote of the electors of the Village of Mount Morris and the electors of the Town of Mount Morris; and

WHEREAS, the Town Board of the Town of Mount Morris and the Board of Trustees of the Village of Mount Morris resolved, that pursuant to the provisions of section of the Town Law, the question of the establishment of said Mount Morris Fire District shall be presented to the qualified electors of the affected districts of the Town of Mount Morris: the qualified electors who reside in the Town of Mount Morris Fire Protection District (or as otherwise formally known), and the qualified electors of the Village of Mount Morris, separately, at special election originally to be held on May 5, 2020, at the Mount Morris Central School District Gymnasium, located at 30 Bonadonna Ave, Mount Morris, New York, between the hours of 12 noon and 9 p.m. and that the Mayor, the Supervisor, the Town Clerk and the Village Clerk be, and hereby are authorized and directed to prepare such documents and to take such actions as may be necessary and/or required to present this question at said special election; and

WHEREAS, on March 7, 2020, Governor Cuomo issued Executive Order Number 202, declaring a State disaster emergency for the entire State of New York, and on June 21, 2020 Governor Cuomo issued Executive Order Number 202.44 declaring that "any village or town election previously scheduled to be held in March, April, May, or June will be held on September 15, 2020".

NOW, THEREFORE, BE IT HEREBY RESOLVED AND ORDERED, that, the Village of Mount Morris, shall submit the question to the qualified electors of the Village of Mount Morris, at special election to be held on September 15, 2020, at the Mount Morris Central School District Gymnasium, located at 30 Bonadonna Ave, Mount Morris, New York, between the hours of 12 noon and 9 p.m. and the ballot will be in substantially the following form, to wit

JOINT RESOLUTION TO FORM JOINT FIRE DISTRICT CALLED MOUNT MORRIS FIRE DISTRICT:

DULY ADOPTED BY THE TOWN BOARD OF THE TOWN OF MOUNT MORRIS AND THE BOARD OF TRUSTEES OF THE VILLAGE OF MOUNT MORRIS ON THE 6TH DAY OF MARCH, 2020, AS PROVIDED FOR IN SECTION 189-A OF THE TOWN LAW, ESTABLISHING THE MOUNT MORRIS FIRE DISTRICT, WHICH SHALL CONSIST OF ALL LANDS WITHIN THE BOUNDARIES OF THE MOUNT MORRIS FIRE PROTECTION DISTRICT (OR AS OTHERWISE FORMALLY KNOWN), AND ALL LANDS WITHIN THE INCORPORATED LIMITS OF THE VILLAGE OF MOUNT MORRIS,
